Tuscarawas County Road & Bridge Department

GENERAL SPECIFICATIONS:

1. Bid prices submitted must be good from April 1, 2010 thru March 31, 2011.
2. The bid shall be awarded to the bidder which has the lowest net price per ton, FOB Plant. In addition, we are requesting delivered prices to New Philadelphia Yard and Port Washington Yard.
3. The lowest net price shall be ascertained by adding a freight factor to each bidder's price for the selected material. The freight factor shall be determined by multiplying a mileage rate of \$3.30 per mile (based on 15 ton load at \$0.22 ton/mile) for the round trip road distance from the respective bidder's plant to the Tuscarawas County Garage at 832 Front Ave., SW, New Philadelphia and to our outpost at Port Washington, Ohio.
4. All material must meet the approval of the Tuscarawas County Engineer and/or his authorized personnel.
5. Material must be available on week days from 7:00 am through 4:00 pm without notice.
6. In the event the supplier is unable to supply, at its place of business, the quantities requested by the County after receipt of a telephone notice from the County, the County shall have the option of purchasing material for immediate use from another supplier.
7. In the event the supplier is unable to supply the materials in conformance with the County's specifications, the County shall have the option of purchasing its needs from another supplier.
8. Estimated quantities listed in the proposal are based upon quantities purchased during the preceding year, and is not a guarantee that similar quantities will be purchased. The County Reserves the right to increase or decrease quantity purchased based upon actual needs without penalty or adjustment of unit prices bid.
9. Bids must be submitted in a sealed envelope marked "ICE CONTROL GRITS" to the Tuscarawas County Commissioners Office at 125 East High Avenue, New Philadelphia, Ohio, prior to the bid opening.
