FURNISHING ASHES FOR TUSCARAWAS COUNTY  
April 1, 2010 thru March 31, 2011

Specifications:

1. The bid price must be good from April 1, 2010 thru March 31, 2011.
2. The ashes shall be furnished from the Suppliers source and/or from County's source (Conesville, OH) and delivered to New Philadelphia and Port Washington.
3. The approximate quantity to be furnished will be a minimum of 10,000 tons. The County reserves the right to increase or decrease the amount and the amount delivered to each location. The County may award to multiple or all bidders as necessary to ensure quantity required can be obtained.
4. Ashes shall be free of foreign material and shall be of a consistency compatible with County's spreading equipment. Bidders will be required to furnish samples of the ashes prior to bid award. The County reserves the right to reject any and all ashes at any time that do not meet our requirements.
5. The bid price must be per ton, F.O.B. to both locations either furnished from bidder's source and/or delivery only cost per ton from County's source at Conesville, OH. Bidders are requested to state the approximate quantity they anticipate that they would be capable of delivering.
6. A weigh slip is required for each load.
7. Bids must be submitted in a sealed envelope marked "Ashes" to the Tuscarawas County Commissioners' Office, 125 East High Avenue, New Philadelphia, OH 44663, prior to the bid opening.
