CORRECT POSTAGE AND ADDRESS ARE ESSENTIAL for all mail to reach our office. Incorrect postage and/or address could cause your payment to be sent to the dead letter office. If you want your tax receipt returned, please enclose a self-addressed envelope with your remittance. According to AM Sub. HB 379, effective September 21, 1982, O.R.C. 323.121 A & B, there will be penalty and interest accrued after the due date.
