



Tuscarawas County Sheriff's Office *Rent Assistance Resources*

➤ Salvation Army Dover – New Philadelphia Corps

Salvation Army Dover-New Philadelphia Corps can provide **rental assistance** for Tuscarawas county residents, in addition to assistance with first month's rent (first month's rent is provided ONLY to those who are considered homeless at the time of need). Rental assistance is available once every 12 months. You will have to attend three appointments on three separate occasions in order to receive this assistance. The appointments will be regarding providing paperwork to take to your landlord to sign and return back, in addition to showing proof of income, the lease (if applicable), and an ID. Once you are approved, the Salvation Army will provide your landlord the rent assistance directly.

Qualifications: 1) You must be at least 30 days behind on rent AND/OR facing eviction; 2) you must be a Tuscarawas county resident; 3) you MUST have a stable/steady income of some sort (you must be able to show proof of this income); 4) you MUST be at or below the 200% Federal Poverty Guideline.

➤ Friends of the Homeless Shelter

The Friends of the Homeless Shelter can assist with rent assistance through two different programs: Rapid Re-Housing and Homeless Prevention. Assistance is available once every 24 months. **Rapid Re-Housing:** Assists individuals with first month's rent and a security deposit for individuals coming out of an institution (jail, sober living house, rehab, homeless shelter, etc). **Homeless Prevention:** Assists individuals who have an eviction notice and/or are "doubled-up" with someone else. This program can assist with up to 6-months of back-rent as well as a security deposit and first month's rent.

Qualifications: **Homeless Prevention:** 1) must have an eviction notice or be doubled up with someone else (i.e. you are staying at your mother's house for the time being); 2) the amount of your rent has to be at or under the rent-reasonable list guidelines (i.e. your rent can not be over a certain amount that is considered "reasonable" for the type of apartment that it is). **Rapid Re-Housing:** 1) you must be coming out of an institution/facility (i.e. a homeless shelter, jail, sober living house, rehab, etc) in order to receive this assistance; 2) you must be within 78 days of homelessness to qualify.

➤ Tuscarawas County Council for Church and Community (T4C) Emergency Assistance Program

Emergency Rental Assistance is available to individuals who have an eviction notice. An individual can apply once within a 24-month period. T4C provides Emergency Rental Assistance to Tuscarawas county residents who have an eviction notice. Up to \$150 can be provided (if the situation is COVID-related, up to \$300 can be provided).

Qualifications: 1) you MUST have an eviction notice; 2) you MUST be a Tuscarawas county resident; 3) you MUST be able to fund the other portion of the rent that you can not cover (other than the \$150/\$300 that T4C provides)

➤ **Alcohol, Drug Addiction, and Mental Health Services (ADAMHS) Board**

The ADAMHS Board provides rental assistance through the **Housing Assistance Program (HAP) Funding**. This funding assists persons with mental illness and/or addiction disorders to obtain and/or maintain housing as part of the recovery process, based on income and factors considered on an individual basis as necessary. Rental assistance is available for those in need of a security deposit, first month's rent, paying a future month's rent, paying the current month's rent, paying back-rent, etc.

Qualifications: 1) must currently be in mental health and/or addiction treatment services; 2) must be following your treatment plan.
