**Emergency Shelter:**

➤ **Friends of the Homeless Shelter (Tuscarawas County)**

Friends of the Homeless of Tuscarawas County is dedicated to assisting families and individuals (men, women, and children) in a faith-based environment to achieve stability, sobriety and permanent housing. You cannot stay at this shelter if you have sexual assault and/or arson in your background. The maximum stay is 90 days. This shelter provides dormitory living (4-6 people per room), and you will be required to complete chores and respect the curfew.

**Homeless Crisis Response Program (HCRP):** funds used to prevent individuals and families from experiencing homelessness and, when homelessness does occur, to provide emergency shelter operations and to rapidly move persons from emergency shelter to permanent housing... 1) emergency shelter 2) homelessness prevention and rapid re-housing activities (households below 30% of the area median income).

➤ **Tuscarawas County Metropolitan Housing Authority**

**Section 8 Housing Choice Voucher Program:** a HUD-funded rental assistance program helping eligible families to find affordable, privately- owned rental units in the Tuscarawas Co. area. TMHA subsidizes a portion of the rent for the tenant family, and pays a Housing Assistance Payment to the participating owner. They only have a limited amount of Vouchers available for use at any one time.

Metro provides a voucher MONTHLY, which assists with paying for your monthly rent. You pay about 30% to 40% of your monthly adjusted income toward rent and tenant utilities, Metro pays for whatever is left over directly toward the landlord.

Metro looks back the last 3 years of your criminal record. If you have any of the following charge-types, you may be disqualified: Violent Criminal Activity, Domestic Violence, Assault, Drug Charges/Convictions, and/or Sex Offender.

➤ **The Salvation Army**

➤ **ADAMHS Board**

**PATH Housing:** transitional housing (short-term) that provides support needed for residents to return to a previous housing setting, move to a permanent housing setting, or a break from a current housing situation. It is an apartment complex unit that assists individuals in transitioning from residential (rehab) treatment OR jail.

**Housing Assistance Program (HAP) Funding (HUD Grants):** assist persons with mental illness and/or addiction disorders obtain housing as part of the recovery process until permanent housing is obtained, based on income and factors considered on an individual basis as necessary. You must be connected with either mental health and/or addiction treatment services to obtain this assistance.

**Permanent Supportive Housing (PSH):** must be: 1) homeless, 2) disabled, **AND** 3) must be coming out of a SHELTER and/or living in a place that is not meant for human habitation (These applications can be completed while still incarcerated)
