Major Subdivision Review Schedule

Major Subdivisions have a three (3) tier review process:

1. Preliminary sketch meeting with the subdivision review committee. No approval from the TCRPC board is needed.
2. Preliminary plat review with the subdivision committee, and approval at a regularly scheduled TCRPC board meeting.
3. Final plat review with the subdivision review committee and approval at a regularly scheduled TCRPC board meeting.

Subdivision review committees will be held approximately 10 days after a request is made to have a meeting. This is to have adequate time to notify members about the meeting
