## RESOLUTION (90-2022) APPROVE PROPOSAL – CLOCK REPAIR

It was moved by Commissioner Landis, seconded by Commissioner Metzger, to approve the Proposal #2 – Option #2 submitted by the Tower Clock Company to make historically accurate repairs/updates to the winding mechanism of the clock located in the court house.

The Tower Clock Company is intimately familiar with the Clock in the Tuscarawas County Courthouse as they have helped to maintain it for many years. Due to the rarity of the Clock and their familiarity with it, the Tower Clock Company is considered to be a sole-source provider for this undertaking, justifying the making of an exception to the county procurement policy.

This will include fabrication of 2 Auto Wind Systems to Replicate the Seth Thomas design originally used to replace weight cable systems.

- 1. All cast iron parts will be cast from patterns made to match the Seth Thomas original winders.
- 2. All parts, motors, gear boxes, pulleys, chain and switches will be of the finest quality and manufactured made in America.
- 3. The original weights and pulleys will be removed from the weight shoots.
- 4. The time side winder will be installed next to the right side of clock.
- 5. The strike side winder will need to be installed on the floor below clock.
- 6. The square arbors on the front of your clock will be fitted with custom made bushings and sprockets.
- 7. All wiring used to power the winders will be coated cable.
- 8. The old pulleys will be cleaned and put on display. 5-year guarantee on all parts and labor

Total Cost: \$32,000.00 (\$16,000 per winder x 2)

**Discussion:** Commissioner Landis thanked Sky Abbuhl, Maintenance Supervisor and Phil Wright, Owner of Tower Clock Company, for the time dedicated to getting the best company to keep the integrity and preservation of the historic clock. Tuscarawas County will now have a clock that is historically correct and working and also safer to work around. There are very few people left who work on these historic clocks.

Commissioner Metzger stated the effort was to make sure we maintained the historic nature of the courthouse, and the clock is part of that. Like Mr. Landis stated, the clock will be in a much safer position, with no worries about the weights going down through the floors. It is a very old mechanism, it has been there for decades. It is time to upgrade the clock winders, but still keep the historical nature of the clock.

Commissioner Abbuhl agreed with both of his colleagues on this resolution. The weights that are currently on the clock are about 800 pounds and run through several floors of the building. There are different things that run through the walls of the building like pipes and wires. If the pullies were to come crashing down, they would cause more damage than we want to deal with. We are keeping everything historically accurate, but it is something that will take us well into the future. Commissioner Landis stated the new pullies will be about 300 pounds and will wind automatically.

Discussion: Jesse Rothacher, Park Manager, stated the Norma Johnson Conservation Foundation Board with a resolution of approval applied for a grant to do improvements along the Johnson Loop at the Norma Johnson Center. They received the money in 2021, but due to the loss of the Soil & Water Conservation District Maintenance employee and the transfer of property between the County Commissioners and Soil & Water, progress was not able to be made on this grant before it expired. The Norma Johnson Conservation Foundation Board and the Foundation for Appalachian Ohio both agreed if the Foundation was able to transfer the grant money to the county, the Foundation for Appalachian Ohio would issue a grant extension for the project. This project will then be able to be started along with the parking lot improvements from the NatureWorks grant. These projects should be completed in Spring of 2022. Commissioner Metzger wanted to know how long the extension on the grant was good for? Mr. Rothacher stated it was good through the summer. Mr. Rothacher will get an exact date for the commissioners.

# RESOLUTION (91-2022) FFAO GRANT TRANSFER FROM THE NORMA JOHNSON CONSERVATION FOUNDATION BOARD

It was moved by Commissioner Metzger, and seconded by Commissioner Landis, to accept the transfer of a \$6,387.35 grant originally awarded to the Norma Johnson Conservation Center Foundation Board by the Foundation for Appalachian Ohio towards Johnson Loop Trail Improvements at the Norma Johnson Center. The Tuscarawas County Park Department will be responsible for implementing the trail improvements and project reporting.

The Norma Johnson Conservation Foundation Board received prior approval from the Tuscarawas County Commissioners to apply for this grant. Due to the transition between the Tuscarawas County Commissioners and the Tuscarawas County Soil & Water Conservation District regarding land and staff at the Norma Johnson Center, this project was not able to be completed within its original time frame. The Norma Johnson Conservation Foundation Board and the Foundation for Appalachian Ohio both approve of this transfer of funds.

The Tuscarawas County Park Department was recently awarded a NatureWorks grant for \$4,125 to perform improvements to the Johnson Loop parking area. These projects will be completed in tandem.

**Discussion:** Dr. Brian Harte, Interim Acting President of Union Hospital appeared via electronic GoTo Meeting and Darrin Lautenschleger, Director of Community Relations of Union Hospital appeared in person. Dr. Harte is the current President of Cleveland Clinic Akron. Dr. Harte is the former President of Hillcrest Hospital in Cleveland and is a physician of General Internal Medicine and still practicing in Akron. There is an active search for the new president of Union Hospital. Dr. Harte's nursing colleague, Sheila Miller, Chief Nursing Officer, Akron is also the interim Chief Nursing Officer at Union Hospital. Dr. Harte is also a Board Member of the Ohio & Erie Canalway Coalition. Dr. Harte's principle priorities have been working with the local medical team to establish and support their priorities and at the same time managing and re-cultivating the size of this latest trend of COVID 19. Tuscarawas County has 13 COVID 19 patients in the hospital right now. There has been 125 COVID 19 deaths since March of 2020. The vaccine mandate for all hospital employees has expired and the hospital lost 10 employees due to this. That is a very small percentage.

Another priority has been maintaining community outreach, supporting the hospital staff and the emergency department (ED) which is the meat of the hospital with the pandemic still ongoing. They have met all challenges head-on and need to be thanked for their good work. The hospital had an accreditation survey which was successfully passed. Every three years every hospital has to demonstrate that it meets all conditions of the CMS program. Union Hospital passed all inspections.

Commissioner Abbuhl introduced everyone to Dr. Harte. Commissioner Abbuhl advised the commissioners contribute financially to the survey to help the hospitals and health departments to complete this survey. Mr. Abbuhl asked how Dr. Harte sees COVID 19 moving forward in the future? Dr. Harte said his crystal ball has been wrong before in predicting the future! The optimism is that COVID 19 may be around for a while with another mutation. This should be the last surge we expect to see for quite some time. The reason for that is because our region is mostly vaccinated or have an immunity. We are somewhat confident that the numbers will stay manageable for quite some time. There is not one community that is going to have baseline number of 0%. We will just have to continue to test the ones that are ill. The virus is going to be something that stays around. As far as masks are concerned, we do not know the answers to that yet. It will most likely be a community by community decision. The medical field is still seeing sick people, but not as much with the COVID 19 as with other

illnesses from the isolation and people not going to the doctor. An example would be a diabetic that has not taken the best care of themselves while being isolated. They are coming to doctor and hospital much sicker than they should be. The medical field is also bracing for the mental health issues that will arise from COVID 19. The mental health issues will affect young and old alike. Commissioner Abbuhl has had his vaccines and his booster and wanted to know if this is going to be an annual vaccination like the flu shot? Dr. Harte did not think this information is known yet.

Commissioner Metzger asked what is the long-term viability of Cleveland Clinic Union Hospital? Dr. Harte stated the hospital is long term. There should be no questions about this what so ever. We are committed all the way. The goal is to bring more and more medical care to Northeast and Eastern Ohio. We made that commitment 4 years ago when Union Hospital joined Cleveland Clinic. That commitment has not waivered. As of January 31, 2022, Union Hospital Cleveland Clinic has accrued about \$10 million in capital investments for things like new MRI machines, Endoscopy equipment, and new facilities for the lab department. These are the kinds of investments we envision for the long term.

Commissioner Landis asked about the aggressive campaign to recruit new doctors to the Cleveland Clinic System at Union Hospital. Are we achieving the goal that was set? Dr. Harte replied his goal is to make sure that Union Hospital has a terrific compliment of generalist and specialty services that serve the needs of the community. We have grown our cardiology, primary care, and specialty presence. There are still some areas like orthopedics, neurologists and electronic medical records to be updated. Mr. Landis stated a couple of weeks ago, a family member of his was at the Union Hospital ED on a Saturday evening and was prepared to be there for the duration. Mr. Landis stated the family member was in and out of there in 2 1/2 hours. The effectiveness and the efficiency of the staff was overwhelming. It was not COVID 19 related but to be in and out was phenomenal under the circumstances the teams are operating. The electronic medical records issue did come up because the medical staff could not compare records with the doctor. Congratulations to Dr. Harte and all of the medical staff at Union hospital. Mr. Landis also wanted to commend Darrin Lautenschleger, Director of Community Relations of Union Hospital, because he does such a great job of communicating and staying in contact with all of the commissioners. He is certainly is asset to the Cleveland Clinic Organization and the community. Thank you.
