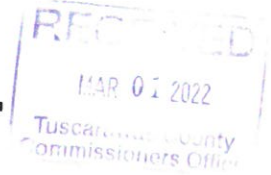

**Discussion:** *Commissioner Landis commented that getting professional help for ARPA clarification is the right thing to do in order to get it right the first time and not have to circle back or give any money back years down the road. Commissioner Metzger thinks the move is appropriate at this time because when the ARPA funds were first released, the rules were hard to understand, and there are still changes being made to the rules. A consultant will be a good thing to be able to get advice and direction on how to move forward with some of the projects being considered. Commissioner Abbuhl noted the Commissioners have reached out to CCAO to get some guidance on some of the organizations that have expertise in the ARPA field. Commissioner Landis added when it is federal money, the county has to be careful when it comes to the bid process because just about everything is going to touch the ARPA funds and it is up to the Commissioners to make sure the funds are engaged properly as well as the people/department who are participating in the program and receiving monies. Commissioner Metzger clarified that ARPA Funds can be used for consultants and ARPA will fund this consultant.*

**Discussion:** *Jesse Rothacher, Park Manager, stated this resolution is an amendment to a pre-existing Technical Assistance Agreement with the Ohio & Erie Canalway Coalition (OECC) that the Commissioners had entered into previously. The monies for this agreement was approved during the 2022 budgeting process and there is purchase order existing for this agreement. The OECC has provided the Park Department with a great deal of help and assistance over the years relating to our mission and goal of completing the Ohio & Erie Canalway Towpath Trail in Tuscarawas County. Commissioner Abbuhl added with Dan Rice and the OECC partnering with the county, we all have been very fortunate to have someone who has such in depth knowledge of the trail systems, understands how it works and how funding mechanisms work. Commissioner Metzger stated the relationship between Dan Rice at EOCC has been so beneficial from where we started, and where we are today, it is night and day.*

- Coordinate the development of the Buckhorn Creek Trail and work with the volunteers assisting with the development of this project.
- Coordinate the implementation of the Tuscarawas County Trail Plan update and provide technical assistance to community partners.
- Coordinate and supervise volunteers working on trail projects.
- Coordinate the development of the Kimble Towpath Trail connection between: a) Zoarville and State Route 416; and b) State Route 416 and Dover
- Assist the City of Dover regarding the development of the Ohio & Erie Canal Towpath Trail.
- Assist the City of New Philadelphia regarding the development of the Ohio & Erie Canal Towpath Trail.
- Assist with fundraising for the Trail Projects.
- Coordinate the presentations regarding the update to the Tuscarawas County Trail and Green Space Plan to the units of government as needed.


