WHEREAS: in 2022, Tuscarawas County lost 21 people to drug overdose death, and experienced 201 recorded overdoses that did not result in death; and

WHEREAS: Every person deserves our best efforts to prevent death from overdose, and it is imperative to support overdose prevention policies and projects and to help make sure everyone understands overdose is an issue that impacts the person struggling with addiction, as well as families, friends, and

WHEREAS: Tuscarawas County Commissioners encourage communities to support local prevention, treatment, and recovery efforts to include Project Hope, Project DAWN, Empower Tusc, and Tuscarawas County Addiction Task Force efforts to reduce stigma, prevent substance use, and make treatment and recovery services available to all; and
