Residential Anti-Displacement and Relocation Assistance Plan

General Information

An Anti-Displacement and Relocation Assistance Plan is required by all grantees prior to funding, whether or not demolition activities are planned. If you have not previously adopted a plan, utilize this format at a minimum to adopt a plan. If you have previously adopted a plan, you may submit an executed copy of that plan in lieu of completing this form (if your activities include demolition or conversion, you will need to get clearance from the Office of Community Development (OCD) prior to proceeding with any demolition or conversion. ATTACH INFORMATION REQUESTED IN THE FORM TO THE PLAN.

Ordinance or Resolution Number: 835-2023 Date: 9/27/2023

Tuscarawas County will replace all occupied and vacant occupiable low- and moderate-income (LMI) dwelling units demolished or converted to a use other than LMI housing as a direct result of activities assisted with funds provided under the Housing and Community Development Act of 1974, as amended, and as described in 24 CFR 570.488. HUD regulation have extended this requirement to the HOME program as well.

All replacement housing will be provided within three years of the commencement of the demolition or rehabilitation relating to conversion. Before obligating or expending funds that will directly result in demolition or conversion, the community will make public and submit to OCD the following information in writing:

- A description of the proposed activity
- The location of each site on a map and the number of dwelling units by bedroom size that will be demolished or converted to a use other than as LMI dwelling units as a direct result of the assisted
- A time schedule for the commencement and completion of the demolition or conversion:
- The general location on a map and approximate number of dwelling units by bedroom size that will be provided as replacement dwelling units;
- The source of funding and a time schedule for the provision of replacement dwelling units;
- The basis for concluding that each replacement dwelling unit will remain a LMI unit for at least 10 years for the date of initial occupancy;
- An analysis determining whether a dwelling unit proposed to be demolished is occupiable or not; and
- An analysis determining whether a dwelling unit proposed to be demolished or converted is considered a LMI unit.

Tuscarawas County will provide relocation assistance, as described in 24
CFR 570.488, to each LMI household displaced by the demolition of housing or conversion of a LMI dwelling to another use as a direct result of assisted activities.

Consistent with the goals and objectives under the Act, the Community agrees to provide substantial levels of assistance to persons displaced by HUD-assisted programs and will further seek to minimize displacement of persons as a result of assisted activities

DISCUSSION: PAINT TUSC PINK - BREAST CANCER AWARENESS MONTH

Darrin Lautenschleger, Director of Community Relations, Cleveland Clinic gave some background on Breast Cancer Awareness Month for this year, Mr. Lautenschleger introduced Dr. Rogers and Raena Beans, Breast Care Coordinator, she is a key person for patients and the staff in the radiology and mammography departments at the hospital.

Breast Cancer Awareness Month is about 20-25 years old. Paint Tusc Pink is 17 years old and was started by the hospital's Community Health & Wellness nurses to address the Community Health Needs Assessment. The first health assessment that was done, showed that women in Tuscarawas County had a higher than normal rate of breast cancer. More alarming was the low number of regular mammograms completed which was in the 40 percent area. This is very a low number. Paint Tusc Pink was born to bring a number of organizations together to start to promote the importance of regular screened mammograms for early detection and successful treatment of breast cancer. As a result of this, the number of mammograms has gone up and the number of breast cancer deaths has gone down.

Commissioner Abbuhl emphasized the importance of pre-screenings. It is good that the message is getting out there and the message has been effective in getting more people in for screenings.

Mr. Lautenschleger stated Breast Cancer Awareness Month has taken on a life of its own and organizations will hold their own fundraisers and events and donate the money to the Breast Care Center at the hospital. This is the largest Public Relations Event of the year for the hospital.
