Discussion: Sanitary Engineer, Michael Jones was present to talk about updates on the Dundee Water System Expansion Project. In 2020, the Tuscarawas County Metropolitan Sewer District (TCMSD) received a Petition from property owners in the area that were interested in receiving public water. A feasibility study was performed by TCMSD. Michael met with the Commissioners to request to be able to solicit qualifications of engineering firms to do the design. Engineering Associates out of Wooster, OH was chosen and a contract has been negotiated. We are to a point now that we need to decide which way we are going to go with this project. The County does have the capacity to serve this area. There are potentially 41 properties who would have access to water. There was a survey sent out by TCMSD in June, 2021, and 21 surveys were received back. There were 17 in favor and 4 opposed.

The original estimated project cost was \$679,500. Cost for engineering would be \$50,000. Commissioner Metzger asked if the engineering fee was included in the original cost? Mike stated that it was included. There are options for the Design Phase financing.

The Commissioners decided to leave any decisions to be made on this project until the new Board of Commissioners takes office in January 2023.
