

OTHER BUSINESS: Commissioner Abbuhl stated that on March 16, 2023, he attended a Legislative Briefing with the County Commissioner's Association. Senator Landis, Representatives Hillyer, Wiggam and Holmes were able to attend. We discussed house Bill 1, regarding property taxation and income tax rates and Broadband Connectivity to get everyone connected. The Legislature right now is focusing on working with the Counties in regards to Local Government Funds and trying to get some of that restored.

It was a good discussion and they are meeting all across the state. I look forward to the outcome, hopefully in a positive way. The County Commissioner's Association staff is working very hard with the Legislature and keeping the lines of communication open in that regard.

IT DEPARTMENT ANNUAL REPORT: April Beachy, IT Director, John Gray, Assistant Director and Larry Lindberg, Auditor, were present to present the Annual Data Processing Board's 2022 Report. April stated in the report are meeting dates, highlights, last five years of the budget and purchases that have been approved by the IT Director this past year.

The purchases amount was \$384,088. The largest purchase last year was the anti-virus removal update/renewal which allows the vendor to monitor our system twenty-four a hours a day. Also last year, we implemented the multi-factor and this was also a big purchase, the new help desk, this has been very helpful, and the new mail filter for SPAM & viruses, there is a glitch in this system. The vendor thinks they have it fixed and will release it on the next revision.

The website is to the point that the offices are using it. As soon as this is completed, we will probably start to look elsewhere because we have outgrown the website already. The phone system switches are at end of life and we have already budgeted for those, but have not had the time to implement this. We are in the process of upgrading our firewall. We are also in the process of implementing wireless at the Sheriff's Office. They will have their own network. The email server will be upgraded in 2024 and this is going to be a large and complex project.

Larry stated there will need to be some additional funds moved to the equipment budget. This was put into the budget at one point during the October process, but it was not completed and is not in the Capital

Funds. There will be a Supplemental of \$5,000.

April has been working with Sky, Maintenance Supervisor, to try and open up the IT Offices because with all five employees in there, it is hard to move around. This will probably have to be a 2024 budget request. The IT Department is fully staffed at this point.

ONEOHIO REGION 11 UPDATE: Kerry Metzger, OneOhio Board. OneOhio is the Opioid Region that was created for the Counties. There are seven Counties in our Region. Tuscarawas County is Region 11. Mr. Metzger stated the opioid settlement was made some years back and the State of Ohio had to set up a structure in which to receive the settlement monies and determine how they are going to distribute these dollars. It has taken longer than everyone had hoped, but when creating a whole new organization from scratch, it takes time. This is still a work in progress.

Region 11 met in October, 2022, to determine who the seven counties want represented on the State Foundation Board. Region 11 selected OMEGA because all seven counties are in OMEGA. Region 12 also has three counties in OMEGA. Jeanette Wierzbicki, OMEGA Director, is the member for the State Foundation. The By-Laws were also voted on during the October, 2022 meeting. The next meeting was February, 2023, and the task of developing leadership positions started. March, 2023 will be the third and at this point leadership will be selected. Last month the OneOhio Region 11 met and set up week for the first time and started to develop criteria as to how to score the different potential projects. At some point and time, the Foundation will start to receive projects and a determination will have to be made as to what projects are of the most value and prioritize within our region. In the interim, we also have to keep in mind, it is not just the value of the project, but also how much money is available to the region.

Commissioner Abbuhl asked who else was on the Grant Committee? Mr. Metzger replied Commissioner JP Dutton, Mayor Cyndi Baronzzi Dickey, of Salem, and two other Commissioners make up the Board. The Grant Committee will review the projects and make their recommendations to the Region 11 Board. The board will approve the projects and send them on to the State Foundation and the State Foundation will make the final choice.

Over the next eighteen years, the state of Ohio is going to receive about \$1 billion in settlement dollars. Initially, a lump sum will be allotted and then it will be smaller as the years go by. The monies can be used for several things such as; treatment, early intervention and crisis support, address the needs of criminal-justice involved persons, mother-centered treatment and support, recovery support, prevention, prevent over-prescribing of opioids and other drugs of potential misuse, prevent overdose deaths and other harms, services for children, first responders, and workforce. If you would like further information on how this process is set up and how it will work, please go to OneOhio.com.

Commissioner Abbuhl stated early intervention and crisis support and prevention are two very important ones to address. If we can stop the issues from the start, then we don't have the issues at the end. Particularly with young kids. They should be educated on these types of issues and things that are happening with marijuana. All of the strategies are important, but early intervention and prevention are my top picks.

Commissioner Zemis thought mother-centered treatment and support were important in respect to addicted mothers and babies. This is a cycle that just keeps going on and on and on. When the new mothers do not have a support system, they can feel desperate and over whelmed and fall right back into old habits. This is very important to both the mother and the children.

Mr. Metzger stated he would like to come back every quarter and update the Commissioners on OneOhio Region 11.

**EMPOWER TUSC:** Kerry Metzger & Jodi Salvo were present to talk about Senate Bill 9, Expansion of Ohio's Medical Marijuana Program. Empower Tusc's mission is to empower the Tuscarawas County Community to prevent the use and misuse of substances and mental health wellness by implementing effective prevention education and other strategies. The vision is to empower our youth to live healthy, drug-free lives. Empower Tusc is growing and is not just about youth drug use and misuse. We are also dealing with suicide prevention and now gambling prevention.

Our main topic today is Senate Bill 9. Empower Tusc has big concerns about the passage of this bill as it is currently written. SB 9 was introduced on 1-11-23 and the passage of this bill will greatly harm the youth of our community and the state of Ohio. It will decrease the perception of harm for marijuana use and increase the usage of marijuana in adolescents and young adults. If we are going to continue to call marijuana "medicine", what do you think the youth are going to think? They are going to think it must be safe because it is "medicine." This is why the prevention community has a lot of trouble trying to address the issue.

SB 9 will remove regulation decisions from the Board of Pharmacy to the Department of Commerce. It removes the regulatory control from the medical community, Board of Pharmacy, to one that focuses on business, Department of Commerce.

Jodi stated that the safeguards that are in place on marijuana as medicine are working. You don't necessarily see the impact in communities because advertising has to be approved through the Department of Pharmacy. You can not have signage, there are qualified diagnosis. There were a lot controls, and use of marijuana had to be done by a physician certified to prescribe. Ohio is finding out what every state before them has seen. The medical program does not produce the revenue the states would like to see. The protocol seems to be; we put in a medical program, we expand it, and then we flip it. It is nearly impossible to teach our youth the harms of marijuana use when their parents are using it as medicine. Kids today do not want to smoke it, they want to vape it, eat it, or drink it because it is easier to conceal. It tastes better, it is an easier product. The schools are having problems with gummies, vaping, and edibles.

Mr. Metzger stated SB 9 will allow unregulated advertising such as on social media or otherwise without prior approval. Opening advertising on all social media will harm our youth. Advertising creates a decrease perception of harm among our young people and will increase marijuana usage among our youth. Advertising had a big impact with Big Tobacco back in the 1950-60's. Tobacco was marketed as healthy, all natural and had medical benefits. It hooked generations upon generations.

Jodi added that they get funding opportunities all the time to deal with the mental health crisis and suicide issues that we have in Ohio, and what did we do? We legalized sports betting! Again, for people over 21 years old, but it is also in the face of young people. We keep saying we need to help the young people in our communities, but we keep putting things right in their face. The highest connection on suicide is gambling. The highest connection for youth with states that have legalized it is marijuana. It is like we are trying to put gasoline on a smoldering fire.

Mr. Metzger said there are 25 qualifying conditions for medical marijuana and SB 9 is going to add 6 more. There is a catch all provision to allow certified physicians to write a medical marijuana

prescription for any condition they see fit. The physician will no longer have to conduct an examination of the patient. The new bill wants a ration of one retail dispensary per 1,000 registered patients up to 300,000 patients. There are 69 retail dispensaries in Ohio as of now.

Mr. Abbuhl asked what is the medical field saying about the medical marijuana? Jodi stated that all major medical associations are opposed. They have written official statements to this effect.

Mrs. Zemis wanted to know why is that "real" medicine comes in child proof bottles and caps so children can not get into it, but marijuana comes in so many different varieties that look good to kids? Mrs. Metzger stated at Empower Tusc, they give away lock boxes so adults can lock up their edibles, marijuana and other products and keep it away from our children.
