VOTE: Chris Abbuhl, yes; Kristin Zemis, yes; Greg Ress, yes; **Discussion:** Commissioner Zemis inquired as to whether this is a normal process for documents to be brought up at the last minute like this? Commissioner Abbuhl answered this is only done when for some reason it was turned in late or the funds are needed immediately. This is not a normal process. The clerk clarified this document was missed in the Auditor's office when the supplementals were being done. It should have been in last week's meeting.

Commissioner Zemis and Commissioner Ress asked if it is normal to have this many supplementals during regular meetings. Commissioner Abbuhl answered this is normal. The departments are just readjusting, for the beginning of the year. If it is coming from their own unappropriated balance for various reasons, they need to supplement a specific line item. This would not be unusual.

Commissioner Ress brought up getting together with departments quarterly or mid-year to discuss their budgets and see where they are within those budgets. Is this something we would want to start scheduling as discussed in a past meeting?

Commissioner Abbuhl stated a meeting can be done if someone would like to coordinate it. We usually do a mid-year review to see where we are half way though the year, but we don't typically call the department heads in, we review it ourselves and make sure that everything is in line. We can do quarterly, or we can do mid-year. The other safe-guard we have is the Auditor's Office who continually monitors this as well and will notify us if any department is in the red.

SOUTHERN COURT: Kathy Werntz from Southern District Court was present to talk about the Sick Leave Donation Program Southern Court would like to implement. Kathy stated she has been with the County for twenty-eight years have never been faced with this situation before. The lady in question came to work in Southern Court in January, 2022. She was at the Health Department for 15 years before going to Southern Court. While employed there, she had accrued 330 hours of sick leave which would have transferred to Southern Court when she came over. During COVID and being in the Health Department atmosphere, this person was required to quarantine several times for exposure to COVID. During the course of these quarantines, the bulk of her built up sick time was used.

She went to the hospital with acute pancreatitis and gall bladder issues. At this time, she had approximately 40 - 50 hours of sick time left. She had surgery, and has returned to work. At this point, she is -10 hours of sick time. There are five people in the office who have well over 240 hours accrued each and are willing to donate if they are granted this program.

Commissioner Abbuhl asked if she had 330 hours when COVID hit and her time is diminished from COVID isolations? Ms. Werntz stated yes, because of always being exposed to COVID, they had to isolate more than others and were required to use their sick time to do so. At the beginning of COVID, quarantine time was 14 days, and then 10 days, and now 5 days. She has been at work since coming to Southern Court.

Commissioner Zemis stated she is glad Ms. Werntz came in because this is definitely a unique situation and not at all what she was thinking.

Commissioner Ress stated he was glad Ms. Werntz came in because he was just in Columbus for County Commissioners training and this subject came up, and from the CCAO Board, this kind of program is frowned upon for a number of reasons. This becomes more personal since we all know each other. Ms. Werntz stated it is also an extenuating circumstance.

Commissioner Zemis wanted to know what kind of safe-guards are in place so the program is not abused or favoritism showed, etc. Ms. Werntz stated the judge has to review all requests. It is for employee, spouse, child or adopted child. The people who donate will also be kept confidential. No one will know who donated to who or how much.

RESOLUTION (213-2023) SICK LEAVE DONATION PROGRAM - TUSCARAWAS COUNTY SOUTHERN COURT

It was moved by Commissioner Zemis, seconded by Commissioner Ress, to approve the following Sick Leave Donation Program as permitted by R.C. 124-391 contingent upon further review, clarification and changes made to policy as discussed in meeting on record:

SICK LEAVE DONATION PROGRAM

A. **Policy**: As permitted by R.C. 124.391, the Tuscarawas County Court will allow eligible employees to donate accrued but unused sick leave on a limited basis to another eligible employee who has a serious health condition, or who has an immediate family member who has a serious health condition, as defined below.

Eligibility for Family and Medical Leave (FMLA) is a separate matter and a FMLA certified claim does not guarantee that an individual will be eligible to receive donated leave.

The Judge reserves the right to approve or disapprove applications to donate sick leave or applications to receive donated sick leave and may request a second opinion at the expense of the Judge.

B. **Purpose**: The intent of the leave donation policy is to allow the County Court employees to voluntarily provide assistance to their co-workers who are in critical need of leave due to an extended illness or injury of the employee or a member of the employee's immediate family.

C. Definitions: For the purpose of this policy the following shall apply:

Immediate family member: the employee's spouse or employee's biological or adopted child

Serious health condition: an illness, injury, impairment, or physical/mental condition that requires hospitalization and/or involves a period of incapacity or treatment that requires absence from employment for more than ten work days, with at least five of those workdays being without pay, for each specific case of serious illness. Additionally, in the case of an employee's immediate family member, the condition must require the care and attendance of the employee.

Transferee: the employee in need and approved to receive donated sick leave.

Transferor: the employee volunteering to donate their sick leave.

D. Hours Transferred: Any hours transferred shall be transferred at the rate of pay equal to that pay of the transferree.

E. Receiving Leave: An employee may receive donated leave equivalent up to the number of hours the employee is normally scheduled to work each pay period or the equivalent of the employee's normal biweekly earnings, whichever is less, and up to twelve (12) weeks for a fifty-two (52) week period, if the employee to receive donated

leave or a member of the employee's immediate family has a serious health condition, the request is approved by the Judge, and the employee:

 has no accrued paid leave; and
 has applied for any paid leave or benefits program for which the employee is eligible; and

eligible; and 3. has applied for Family and Medical Leave (if eligible); and 4. leave taken under this program will be included and is subject to the 12 week limits of the Family and Medical Leave Act (if applicable); and 5. has no documented abuse or patterned use of sick leave; and 6. has provided acceptable written verification that the extended illness exists; and 7. is not receiving workers' comp or OPERS disability compensation; and 8. agrees to accept the leave under the terms of this policy and completes an "Application to Receive Donated Leave" form.

F. Donating Leave: Employees may donate leave if the request is approved by the Judge and the donating employee

is not a member of the receiving employee's immediate family as defined above;
 voluntarily elects to donate sick leave and does so with the understanding that donated leave will not be returned;
 donates a minimum of hours equivalent to one of the donor's regularly scheduled workdays in one donor day increments;
 retains a sick leave balance of at least 240 hours;
 completes an "Application to Donate Leave" form.

G. Administration: The leave donation program shall be administered on a pay period to pay period basis. The Judge as the Appointing Authority shall review the Application to Receive Donated Leave and the Application to Donate Leave to assure compliance with this policy. Donations of sick leave will be recorded in the order of their submission, and will not be considered actually donated nor be deducted from the transferor's balance or credited to the transferee's balance until the pay period such leave is actually used. Unused donation applications shall be returned to the transferor. Employees using donated leave shall be considered in active pay status and shall accrue leave and be entitled to any benefits to which they would otherwise be entitled. Vacation and sick leave accrued by an employee while using donated leave shall be used, if necessary, in the following pay period before additional donated leave may be received. Donated leave shall never be converted into a cash benefit. The Appointing Authority leave shall maintain such records as are necessary for the administration of this program.

H. Certification: Employees who wish to donate sick leave shall certify:

The name of the employee for whom the donated leave is intended;
 The number of hours to be donated;
 That the employee will have a minimum sick leave balance after donation of at

least 240 hours;

4. That the leave is donated voluntarily and the employee understands that the donated leave will not be returned, unless per G above.

I. Confidentiality: The Judge as the Appointing Authority shall ensure that no employees are forced to donate leave. Appointing Authority shall respect an employee's right to privacy, however Appointing Authority may, with the permission of the employee who is in need of leave or a member of the employee's immediate family, inform employees of their co-worker's critical need for leave donations from employees. The donation of leave shall occur on a strictly confidential and voluntary basis.

J. Applications: Employces wishing to donate or receive donated leave may pick up applications from Kathy Werntz of the County Court.

We will have something in writing and something on record so everyone has a clear understanding of the situation.

We were to have a bid opening at 9:45 a.m. for the Wilkshire Hills Water System Improvement and there was some information that was not transferred or miscommunicated with the Thrasher Group. Mr. Abbuhl asked Mr. Jones to explain what happened. We also have a resolution considering postponing the bid due to circumstances.

Michael Jones started out by stating the primary source of funding for this project is combination Revenue Bond and Grant through USDA Rural Development. Friday, March 10, 2023, Mr. Jones received a call from the USDA State Engineer stating the he had reviewed our most recent specifications submittal from Thrasher Engineering. There were certain USDA required documents that were not included in the bidding documents that are essential for awarding the project.

We needed to decide if were going to go ahead and open bids and reject them and re-bid, which would delay the project even further or just simply postpone the bid. There was a conference call between myself, Rhonda Jordan, Clerk of Board, Ryan Styer, Prosecutor and Steve Anderson, Special Counsel. Both attorneys were in consensus that the Board did have the ability to postpone the bid. Yesterday afternoon, Thrasher Engineering issued an addendum to all plan holders that included an electronic notification and also reached out to every plan holder by phone to personally notify them that the bid date had changed.
