Discussion: Mike Jones, Sanitary Engineer was present and stated the Port Washington Sewer System was approved for \$100,000 in ARPA funds for a generator, but since this resolution was approved, there have been some changes. The generator project needs to remain on the Capital Improvements list, but a more pressing issue has arisen. This pump station pumps into a 3.6-mile force main that extends to the Village of Newcomerstown. Along the route of this force main, there are 14 air release valves. Earlier this year it was noticed that there is a significant reduction in the pumping capacity at this pump station, to the point of having to rent a large pump station/by-pass pump to keep from flooding the town. Even with the rented unit, the pumping capacity is still not anywhere near where it needs to be.

After researching what the cause of the issue is, it has been determined there is a large amount of accumulative air in the forced main. The 14 air release valves were installed in the 1980's, the useful life of the valves is about 20 years. Each of the valves have been located, and they are in varying stages of decay. A large number of the valves are not functional at this time. The pump should be pumping 250 gallons a minute, but is only pumping about 90-100 gallons per minute. The large pocket of air can not

be released without the air release valves. The crews have tried to bleed the air out of the lines, but could not get all of it. Mr. Jones is requesting to shift priorities on what the ARPA funds are being used for. It will be the same site, but different project.

Commissioner Landis asked if there were parts around the valves that may be damaged as well since they are so old? Mr. Jones said there is a good possibility of this. The right contractor will need to hired because when you are dealing with a live force main with almost 4 miles of sewage in it, if something goes wrong, there is 4 miles of sewage that has to be dealt with immediately. This project needs to be done very carefully with contingency plans in place. The estimate for this project is roughly \$112,000 and getting the parts could take up to 7 weeks.

Commissioner Metzger asked if the generator project is being deprioritized and the forced main project is the priority, or could both projects be done at the same time? Mr. Jones stated this could not be done because the generator project would need an electrical contractor and the forced main valves would need a pipeline contractor.

RESOLUTION (468-2022) – AUTHORIZE CHANGE - SCOPE FOR PROJECT ID #PW-21-01 – PORT WASHINGTON SEWER SYSTEM

It was moved by Commissioner Metzger, and seconded by Commissioner Landis, to approve the foregoing resolution:

WHEREAS, the Board of Commissioners, Tuscarawas County, Ohio ("Board") have approved \$100,000 in American Recovery Plan Act ("ARPA") funds for Project ID #PW-21-01 Port Main Pump Station – Emergency Generator/ATS, and

WHEREAS, the Sanitary Engineer, Michael Jones, has recommended that the replacement of force main air valves is essential and critical to the operation of the Port Washington Sewer System, and

WHEREAS, the Sanitary Engineer, Michael Jones, has requested that the scope of Project ID #PW-21-01 be modified for the replacement of the force main air valves in lieu of the installation of a standby generator.

NOW THEREFORE BE IT RESOLVED by the Board of Commissioners, Tuscarawas County, Ohio:

<u>Section 1</u> – That the request for a change in scope for Project ID #PW-21-01 is hereby approved with \$100,000 in ARPA funds being allocated for direct costs associated with the project.

Section 2 – That pursuant to ORC 6117.06(E), the Board finds that the improvement is necessary for the preservation and promotion of the public health and welfare, and has determined that no special assessments are to be levied to pay any part of the cost of the improvement; and

<u>Section 3</u> – The Board hereby authorizes the Tuscarawas County Sanitary Engineer, Michael Jones, to provide notice of competitive bidding in the form and manner specified in ORC 307.87 and the Tuscarawas County Procurement Policy, with a copy of such notice being attached hereto.

<u>Section 4</u> – It is found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were passed in an open meeting of this Board and that all deliberations of this Board that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

RESOLUTION (470-2022) BRINE PERMIT – BELDEN BRICK COMPANY

It was moved by Commissioner Landis, seconded by Commissioner Metzger, to accept the brine permit for Belden Brick Company:

The Tuscarawas County Commissioners wish to permit the surface application of brine by Belden Brick Company. The source of the brine water will be from the Belden Brick Company's gas and oil wells located in Tuscarawas and Holmes County. The brine will be transported and applied with certified brine haulers, primarily with the Belden Brick Company's truck.

The brine water will be applied for dust and ice control on Belden Brick Company private property.

Therefore the Tuscarawas County Commissioners hereby adopt the following resolution which grants Belden Brick Company, the right to apply said brine to the road surfaces of above-mentioned roads.

Prior to the acceptance of this resolution permitting surface application of brine, a public hearing was held at the Tuscarawas County Commissioner's Office, New Philadelphia, Ohio. A notice of the time, place, and content of hearing was published by the Tuscarawas County Commissioners in "The Times Reporter", a newspaper of general circulation in Tuscarawas County, Ohio, at least five days prior to the date of the public hearing, and the fifty dollars (\$50.00) permit fee having been paid as required in H.B. 501-1590226H.

The surface application of brine in Tuscarawas County shall be regulated as per O.R.C. 1509.226 as follows:

- (1) Brine shall not be applied:
- a. To a water saturated surface;
- b. Directly to vegetation near or adjacent to surface to be treated;
- c. Within twelve (12) feet of structures crossing drainage ditches;
- d. Between sundown and sunrise except for ice control;
- (2) The discharge of brine through the spreader bar shall stop when the application stops.
- (3) The applicator vehicle shall be moving at least five (5) miles per hour while the brine is being applied.
- (4) The maximum spreader bar nozzle opening shall be three quarters (3/4") of an inch in diameter.
- (5) The maximum uniform application rate of brine shall be three thousand (3,000) gallons per mile on a twelve-foot (12') wide road, or three (3) gallons per sixty (60') feet on unpaved lots.
- (6) The applicator vehicle discharge valve shall be closed between the brine collection point and the specific surfaces that have been approved for brine applications.
- (7) Any valve that provide for tank draining other than through the spreader bar shall not be greater than sixty (60) degrees from the perpendicular to the unpaved surface.
- (8) Only the last twenty-five (25%) percent of an applicator vehicle's content shall be allowed to have a pressure greater than atmospheric pressure; therefore, the first seventy-five (75%) percent of the applicator vehicles contents shall be discharged under atmospheric pressure.

Furthermore, be it known that a copy of this resolution permitting the application of brine to Belden Brick Company private property, shall within thirty (30) days after the adoption of the Resolution be submitted to the Chief of the Division of Oil and Gas of the State of Ohio.

Discussion: John Fondriest, Chair Person and Jill Lengler, Director, both of Regional Planning were in attendance to present a draft of the 2023 budget for Regional Planning. Mr. Fondriest stated Mrs. Lengler is planning to retire at the end of June 2022, but has agreed to hire back on part-time until the end of 2022. Mr. Fondriest is proposing Mrs. Lengler be paid her current pay, but on an hourly rate based on a two-day workweek give or take 18 hours a week, and dropping her health insurance which will help the budget.

Mr. Fondriest stated the Regional Planning budget was set at \$60,000 in 2004. There have been no rate increases since 2008 when the membership fee was raised by 5 cents per capita over 5 years. In 2012, the Regional Planning budget was increased by \$1,000, it has been 10 years with no increases. In order to keep Regional Planning solvent, our proposal for 2023 is a 20% increase, a 10% increase in 2024 and 2025. This proposal also includes a 20% increase for the villages, cities and townships as well.

The permit fees can be raised immediately.

The expenses are at about \$80,000 and this includes a \$6,000 pay out for Mrs. Lengler's sick leave conversion. The plan is to promote Rhonda Hoffmeyer and hire an assistant for a total expense of \$68,000. The health insurance portion varies and may need to be adjusted.

It was moved by Commissioner Metzger, seconded by Commissioner Landis, to take under advisement the Proposed 2023 Budget for Regional Planning.

Discussion: Kenny Quillen stated the Tuscarawas River clean-up was an idea he had a couple of years ago and the pandemic hit and everything got put on hold. Mr. Quillen made a Facebook post about the cleanup and turning it into an event with prizes and a lunch afterwards. The response Mr. Quillen received from Facebook users was overwhelming from volunteers to vendors. Ron Rosenthal, owner of Hog Heaven Restaurant, offered to host the after party with bands and prizes. Mr. Quillen has about 12 people who would like to start a committee to put the event together.

Mr. Quillen wanted to meet with the Commissioners to see if they had any questions, concerns or advice on how to proceed with the project. Mr. Quillen looked on some river clean up websites and noticed one of the first things coming up was a Waiver of Liability. Mr. Quillen would like to clean-up the entire county from Bolivar to Newcomerstown and divide it into sectors.

Commissioner Metzger advised the Ohio Department of Natural Resources is in control of the riverways and that might be a good place to start the process. Jane Clay, Executive Assistant, suggested also contacting the Muskingum Watershed Conservancy District who has the river designation there and they could be helpful in the process. It is also going to depend on what land your organization is going to be utilizing for access to the river. Commissioner Abbuhl added the river does run through a portion of the Tuscarawas County trail system. Mr. Quillen stated he wants to talk to the businesses along the river to get them on board. Mr. Quillen also wants to talk to Kimble Company about getting dumpsters set up along the route. Commissioner Metzger stated the only way the commissioners would be involved is if access to the river was needed from the county's park properties. Mrs. Clay recommended Mr. Quillen get in touch with Camp Tuscazoar because they just did a river clean up a couple of weeks ago, and also recommended Mr. Quillen talk with Jesse Rothacher, Park Manager, about a special usage permit, access permits and liability insurance coverage. It will depend on whose land is being used as to what the process is and what forms may be needed.
