RESOLUTION (519-2022) AUTHORIZE ADVERTISEMENT/PROCUREMENT – ARCHITECTURAL/ENGINEERING SERVICES - COUNTY MULTI-USE BUILDING PROJECT

It was moved by Commissioner Landis, seconded by Commissioner Metzger, to authorize the advertisement/procurement of architectural/engineering services for the New County Multi-Use Building Project that will be funded by the American Recovery Plan Act of 2021. The procurement process will include an advertisement in the local newspaper along with direct solicitation packets being mailed to various architectural/engineering agencies or firms. These actions were taken based upon the recommendation of Scott S. Reynolds, Director of the Tuscarawas County Office of Community & Economic Development.

PUBLIC ANNOUNCEMENT

The Tuscarawas County Board of Commissioners intends to contract for Architectural/Engineering services in connection with the design and construction of a New Multi-Use County Facility that will house at least initially the Board of Elections and a Records storage facility. Architectural/Engineering firms that are interested in a contract to provide the required services must reply with a statement of qualifications no later than 4:00 P.M. on Friday, July 1, 2022. Statements received after the deadline will not be considered.

Statements of qualifications should include information regarding the firm's history, education and experience of the owner's & key technical personnel; the technical expertise of the firm's current staff; the firm's experience in designing similar projects; *the firm's experience in working with Federally funded projects; availability of staff; the firm's equipment & facilities; references; and any previous work performed for the Tuscarawas County Board of Commissioners. A more extensive scope of services and the evaluation criteria that will be utilized by the County in our review of all responses will be made available upon request.

Three Copies of a "Statement of Qualifications package" should be submitted to the Tuscarawas County Office of Community & Economic Development, 125 East High Avenue, Room 212, New Philadelphia, Ohio 44663 prior to the deadline.

Responding firms will be evaluated and ranked in order of their qualifications. Following this evaluation, the Tuscarawas County Board of Commissioners will enter into negotiations with the most responsive and qualified firm.
