WHEREAS, the State of Ohio, Department of Development, Office of Community Development, has offered 3 options for applying for the program, with Option No. 3 being that the County may appoint an agency to apply on the jurisdiction's behalf; and

WHEREAS, Ohio Regional Development Corporation, hereinafter the "Agency", is an Ohio non- profit Corporation engaged in community and economic development, planning and housing, and located in the City of Coshocton, Ohio, and has agreed to apply for the program on behalf of Tuscarawas County and to administer the program within Tuscarawas County, whereby ORDC will be the "Responsible Party" and will execute a grant agreement directly with the State of Ohio, Department of Development, Office of Community Enhancement; and

WHEREAS, this agreement is in effect until the PY2023 Lead Safe Ohio Allocation Program funds are expended and the funded activities are complete and closed out.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners, Tuscarawas County, Ohio:

<u>Section 1</u>: The Tuscarawas County Commissioners hereby designate Ohio Regional Development Corporation as the "Appointed Agency" to apply for the PY2023 Lead Safe Ohio Allocation Program on behalf of Tuscarawas County and to assume the role of "Responsible Party" for the \$788,000 in funds allocated to Tuscarawas County.
