**DISCUSSION: UPDATE ON ROSWELL SEWER SYSTEM;** Mike Jones, Sanitary Engineer, and Nick Mill, ADR Vice President were present to give an update on the Roswell Sewer System Project. **Mr. Jones** stated this project has been in the works since 2013. ADR started out as the Village of Roswell's engineer when the Environmental Protection Agency (EPA) started issuing them notices of violations for some stream sampling. Once the County became involved, we wanted to look at a more holistic approach and also look regionally because we do have other facilities in the area. This is kind of a follow-up to the Regional Facilities Plan that was done for the Midvale/Barnhill area.

Mr. Mill gave an overview of issues the Village of Roswell is facing. Mr. Mill stated Roswell has some places that do not even have storage tanks, the wastewater just dumps into the stream. The indication of a problem came in 2013 when the EPA found E-Coli positive samples. It was 2018 when the EPA started putting pressure on the Village to fix the issue. ADR got involved around this time and did an engineer's report with Mike. This then became a more comprehensive report. There are two options; Roswell is the genesis of the whole project and we wanted to make sure we took care of that first and foremost. We also wanted to look at a regional option to keep the per-capita costs down.

The project can be done, but there was no combination of funds that we could get to total \$30 million. The Roswell project is a much smaller capital project, just not as efficient. We recommend moving forward with the local treatment system. We will keep exploring the regional plan for the future. The estimated project cost would be \$6.8 million. The funding sources would consist of the Army Corps of Engineers, Ohio EPA WPCLF loan with 50% of loan being converted to a grant, Appalachian Regional Commission Grant, Ohio Public Works Commission Grant and the Department of Development Grant. Construction would not begin until 2026 to early 2027.

Commissioner Abbuhl stated we have looked at this project in the past and since then, there has been a change in leadership. Do we know at this point, if all of the leadership and council is supportive of moving forward? Mike stated the first thing he wanted to do was get with the Commissioners and update everyone. The next thing we would like to do is set up a meeting with the Village to go over this with them. We do have the resolution from the Village authorizing the County to establish a sewer district within the municipal corporation of the Village. If we move forward with more financial commitment, I think it is a good idea to have a formal agreement with the Village. Legal is looking into an agreement at this time

Commissioner Abbuhl stated setting up Townhall Meetings would be a good way to inform the public because anytime you are making major changes, the village needs to understand the options are very limited. They have EPA orders that something needs to be done, they do not have the finances to be able to do it themselves, the County is willing to potentially come in and go through the process to make sure the environment and homes are protected because they are too small to put in septic tanks. The village really has no options and we need to make sure the residents realize this is something that really needs to be done for environmental protection and the protection of the homeowners.

*Mike* stated the EPA has not put the Village under Findings and Orders because people are trying to get this built.
