

SPECIFICATIONS FOR  
ASPHALT CONCRETE MAINTENANCE MATERIALS

Tuscarawas County Engineer

Material to be bid will be 301-402-404 Asphalt Concrete

GENERAL SPECIFICATIONS:

1. All materials to be bid F.O.B. plant. (Location of plant must be stated on bid sheet)
2. Unit prices bid must be good through the 2024 season.
3. Material must be available on week days with a day's notice from the County Engineer or his authorized personnel.
4. Bids **must be submitted in a sealed envelope marked "Asphalt Concrete Bid"** to the Tuscarawas County Commissioners, 125 East High Avenue, New Philadelphia, OH 44663, prior to the bid opening.
5. The bid shall be awarded on each item bid to the bidder which has the lowest net price per ton for the current period. Lowest net price shall be ascertained by adding the freight factor to each bidder's price for the selected material. The freight factor shall be determined by multiplying a mileage rate of \$5.20 per mile (based on 15 ton load at \$0.37/ton/mile) for the round trip road distance from the respective bidder's plant to the project site.
6. Estimated quantities listed in the proposal are based upon quantities purchased during the preceding year, and is not a guarantee that similar quantities will be purchased. The County reserves the right to increase or decrease quantity purchased based upon actual needs without penalty or adjustment of unit prices bid.

MATERIAL SPECIFICATIONS:

All material must meet the most recent edition of the State of Ohio Construction and Material Specifications (400 Flexible Pavement and 301 Bituminous Aggregate Base) with the following exceptions:

- A. The Bituminous content shall be a minimum of 5.8% for the 402 and 404 asphalt concrete and 5.0% for the 301 bituminous aggregate base. Binder shall be PG 64-22.
- B. Deviation of the mean from the composition must be within 5% for all aggregate designs.
- C. The County reserves the right to take samples of the materials received and have the analysis of test made by the Testing Laboratory of the Ohio Department of Transportation. Two (2) samples will be taken each time and in the event that both samples fail to meet these specifications that days total quantities used will be assessed a 30% penalty of bid price.
- D. If at any time, the supplier cannot furnish asphalt materials that meet the herein stated specifications, the County has the privilege to purchase, from the next lowest bidder, any amount of asphalt materials that it needs.
- E. **No** substitutions, such as 448 Asphalt Concrete, will be accepted in lieu of the 402 and 404 Asphalt Concrete. **No** recycled material will be accepted for 301, 402 or 404.

## TERMINATION OF CONTRACT:

If the supplier should default in any of the items of this contract, the County may, at its option, terminate the contract, upon giving the supplier twenty-four (24) hours written notice. Upon the occurrence of such termination the County shall then be entitled to purchase said asphalt materials from the next lowest bidder and the supplier shall be liable to the County for any additional costs to the County in purchasing said asphalt from the next lowest bidder above the contract price herein contained.
