Bids will be received for a fixed bid margin price per gallon for each location and product specified on the bid form. The bid margin <u>shall</u> include <u>all</u> of the supplier's costs, freight costs to their facility and to each delivery location, monitoring equipment, overhead and profit required. The bid margin price, per gallon, shall be firm for the entire term of this contract.

For the term of this contract, the **OPIS/Benchmark** price for each product will be determined as follows:

-The **Unbranded Low Price**, as set at 10:00 AM and listed for the day of delivery of each product to each entity on the daily OPIS price report for the Akron / Canton Market Area.

-**Supplier** to submit the Fuel Cost Calculation Sheet provided by the County for each participating entity (Sample Attached) along with the OPIS Daily Price Report for each day gas or fuel is delivered to any participating entity.

Please note that the State tax, the Federal LUST tax and the PAT tax shall **NOT** be included in your **bid margin**. The amounts for those items are listed on the Cost Data Sheet (sample included) separately.

Minimum octane rating shall be 87 for regular unleaded. All #2 Diesel shall be Ultra Low Sulfur (Un-dyed Highway) Fuel and for use in Diesel Engine powered equipment and vehicles.

During winter months, fuel to be supplied with necessary additives for operation in cold weather. Suppliers are required to bid a set price per gallon for winter additives in their bid. This additional amount will be added to each gallon of diesel fuel delivered during cold weather months as requested by the county. Time period may vary, but will typically be from November thru March.

Supplier to provide monitoring equipment on all tanks to insure deliveries are made in a timely manner and provide access to the monitoring information to the entities.

Supplier to provide separate delivery tickets for each of the two (2) diesel tanks located at New Philadelphia. Tank #1 is at 812 address and tank #2 is at 930 address.

Supplier to drop off any fuel delivery tickets for the Engineer's Dundee and Zoar locations to the office at 832 Front Avenue SW, New Philadelphia, OH.

Bids must be submitted in a sealed envelope marked "Gas and Fuel Oil Bid" to

the Tuscarawas County Commissioners Office at 125 East High Avenue, New Philadelphia, Ohio 44663, **prior to the bid opening**.
